#### 3.2 The production department is responsible for implementing according to this provision.

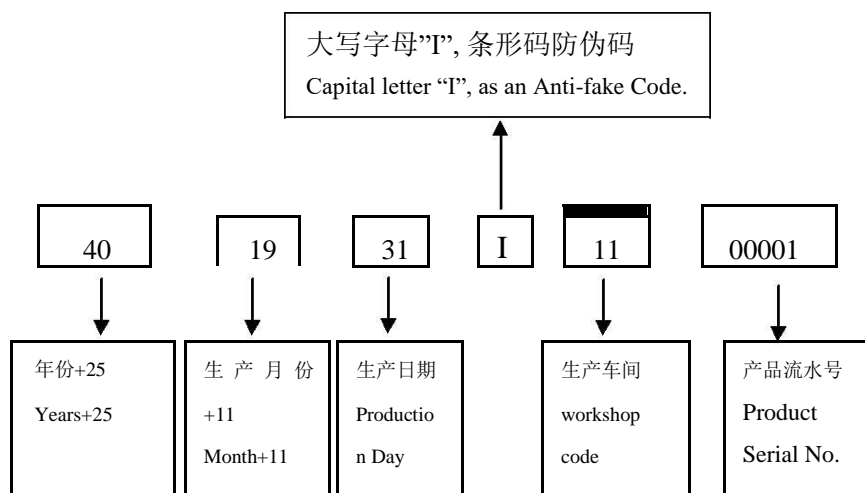

(1) 年份后两位数字+25,即组件寿命周期 25 年

The Years +25 means the production year plus the life time of the Solar Module 25 years.

(2) 月份为当月数字+11。

The Month is the production month plus 11.

(3) 生产日期为具体日期号， 01-31 范围内。

Production Day is the specific date, from 01 to 31.

(4) I 为防伪识别码。

I is the Identical Anti-fake Code

(5) 01-49 代表东方日升车间， 01 代表 1 车间,02 代表 2 车间依次类推,外协工厂用 50-99.

01-49 means the workshop of Risen, 01 indicates workshop I, 02 indicates workshop II by analogy, OEM workshops use 50-99.
